



ASSUMPTION OF RISK, WAIVER & RELEASE OF LIABILITY AGREEMENT

In consideration of being allowed to enter and/or participate in any play activities, party or program at the park facility at Good Times Park of Eagan, Minnesota (the "Park Facility"), the undersigned, on his/her behalf, and on the behalf of the participant(s) identified below, acknowledges and agrees to the following conditions in this assumption of risk, waiver and release of liability agreement (the "Agreement"):

- I represent that I am age 18 years or older and am the parent or legal guardian of the participant(s) named below, or I have obtained permission from the parent/legal guardian of the participant(s) named below to execute this agreement on such parent/legal guardian's behalf.
- I agree that the Park Facility is an unsupervised play facility and that I (as the parent, legal guardian or responsible adult for the participant(s) entering the Park Facility with me) am responsible for monitoring the participant's(') behavior, actions and whereabouts, and for providing overall necessary and standard care for the participant(s) at all times within the Park Facility.
- I agree that the participant(s) named below and I shall comply with all stated and customary terms, posted safety & security signs, Park Facility rules, and verbal instructions as conditions for participation in any play activities, party or program at the Park Facility.
- I agree to stop unsafe, inappropriate or unfriendly play immediately. In addition, I agree to inspect the facilities and equipment prior to using it and if anything is believed to be unsafe or hazardous, I agree to immediately report it pursuant to the Safety Log instructions located on the Health & Safety board in the Park Facility.
- I agree that using the equipment and participating in the play activities at the Park Facility is completely voluntary. I am aware that there are inherent risks associated with participation in the play activities, parties or programs at the Park Facility, and I, on behalf of myself, and (as the parent, legal guardian or responsible adult for the participant(s) entering the Park Facility with me), the participant(s) named below, knowingly and freely assume all such risk, both known and unknown, including those that may arise out of the negligence of other participants.
- I, for myself and the participant(s) named below, and our respective heirs, assigns, administrators, personal representatives, and next of kin, hereby release and hold harmless Good Times Park Inc. and its officers, members, agents, employees, and sponsoring agencies from and against any and all claims, accidents, injuries, liabilities or damages arising out of or related to our participation in any and all of the Park Facility's party, program or activities therein.
- I agree that my use of the Park Facility may be revoked without refund at any time by Good Times Park Inc.'s owners, agents, employees, officers, directors, or representatives for my or participant's misconduct, dangerous activity or violation of any provision of this Agreement. I agree that participant behavior may be monitored through video surveillance.
- I give my consent to and waive any and all rights of compensation or claim, both present and future, in regards to use of media coverage (articles, photos, video footage, quotes, etc.) of my and the participant's(') participation in play activities, party or program at the Park Facility for any purpose including but not limited to marketing purposes.

If any of its provisions are held to be invalid or unenforceable by a court of competent jurisdiction, such holding shall not invalidate any of the other provisions of this Agreement, as the provisions of this Agreement are severable.
